This is a reminder to renew studio dues for 2023-2024 fiscal year. The application on the enclosed form is to be **COMPLETELY FILLED IN** and <u>POSTMARKED NO LATER THAN 11/01/23</u>. There are currently 9 PFMC Festivals Areas: NE Wilkes-Barre, NE Wmsprt, Phil North, Phil Central, Phil South, Pitts East, Pitts North, NW West, NW East **INDICATE ON THE FORM WHERE YOU PARTICIPATE** 

The following information will help determine the dues amount to send

**DUES:** MINIMUM DUES of \$32 covers up to and including 16 students. If you have more than 16 students, multiply the number of students times \$2.00 and send that amount. THERE ARE NO REFUNDS! Your junior students must not have reached their 19<sup>th</sup> birthday before Festival Day.

**<u>NEWS SHEET</u>**: There is no longer a fee for a News sheet subscription. The News Sheet is accessible on the website under Who Are We/Member Information and is password protected.

<u>JUNIOR KEYNOTES MAGAZINE:</u> You receive the magazine as part of your NATIONAL dues. If you have multiple teachers at your studio <u>who have students participating in Festivals</u>, \$6 per additional teach MUST BE added to cover cost for Junior Keynotes. On the back of the enclosed DUES FORM include the name and full address of each additional teacher and the SENIOR CLUB to whom each teacher pays membership dues.

**NFMC POLICY STATES:** any studio head or additional teacher must belong to a FEDERATED Senior Club or must pay Senior Individual Membership fee of \$50.

**DUES** must be **POSTMARKED** NO LATER THAN NOVEMBER 1, 2023. Dues mailed after that date must include a **\$25 LATE FEE** for your students to be eligible to participate in FESTIVALS. If your dues are paid on time, you may claim 10 points on the Junior Club Rating Sheet.

After 11/1/23 Studio Dues NOT PAID by JANUARY 31, 2024, including the \$25 late fee will result in that studio being ineligible for the current year Festivals. PFMC is not interested in collecting late fees! Late payments require additional time to process and submit to NFMC. Please send dues on time and <u>be certain to pay dues for ALL your students participating in Festivals.</u>

If you have students participating in Festivals as **Individual Members**, encourage them to send their fees to NFMC by the Nov. 1<sup>st</sup> deadline. They will receive *Junior Keynotes* from NFMC and be a part of the national organization for the fiscal year. Dues form for Individual Membership can be found on the PFMC website. Follow instructions on that form.
