This is a reminder to renew studio dues for 2024-2025 fiscal year. The enclosed **green form** is to be **COMPLETELY FILLED IN** and returned with a POSTMARK NO LATER THAN 11/01/24.

There are currently 9 Festivals Areas:

NE Wilkes-Barre, NE Wmsprt; Phil North; Phil Central; Phil South; Pitts East; Pitts North; NW West; NW East

INDICATE ON THE FORM WHERE YOU PARTICIPATE

Use the following information to determine the dues amount for your studio.

******DUES:** MINIMUM DUES of \$32.00 covers up to and including 16 students. If you have more than 16 students, multiply the number of students times \$2.00 and send that amount. THERE ARE NO REFUNDS! Your junior students MUST NOT have reached their 19th birthday before Festival Day.

**** **PFMC NEWS SHEET:** There is no longer a fee for a News sheet subscription. The News Sheet is accessible on the website under Who We Are/Member Information and is password protected... for the upcoming season the password will be: 2425Pfmcc!!

******JUNIOR KEYNOTES:** You receive the magazine as part of your NATIONAL dues. If you have multiple teachers at your studio who have students participating in Festivals, \$6 per additional teacher MUST BE added to cover cost for **JUNIOR KEYNOTES**. On the back of the enclosed green form include the name and full address of each additional teacher and the SENIOR CLUB to whom each teacher pays membership dues.

******NFMC POLICY STATES:** any studio head or additional teacher must belong to a FEDERATED Senior Club or must pay the Senior Individual Membership fee of \$70.

******DUES** must be **POSTMARKED** NO LATER THAN NOVEMBER 1, 2024. Dues mailed after that date need to include a **\$25 LATE FEE** for your students to be eligible to participate in FESTIVALS. If your dues are paid on time, you may claim 10 points on the Junior Club Rating Sheet.

******After 11/1/24** Studio Dues NOT PAID by JANUARY 31, 2025, **including the \$25 late fee** will result in that studio being ineligible for the current year Festivals. **PFMC is not interested in collecting late fees!** Late payments require additional time to process and submit to NFMC. Please send dues on time and **be certain to pay dues for ALL students participating in Festivals.**

If you have students participating in Festivals as **Individual Members**, please remind them to send their fees to NFMC by the Nov 1st deadline. They will receive *Junior Keynotes* from NFMC and be a part of the national organization for the fiscal year. Dues form for Individual Membership can be found on PFMC website. Follow instructions on the form.
